Are there services covered before you meet your deductible?	Yes. Complementary Medicine, Preventive Care, and Pharmacy Drugs are covered before the deductible is met.	This plan covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply.
